Update on BDD Operations for the Month of May 2016

#### ITEM:

- 1. This memorandum is to update the Buckman Direct Diversion (BDD) Board on BDD operations during the month of May 2016. The BDD diversions and deliveries have averaged, in Million Gallons Daily (MGD) as follows:
  - a. Raw water diversions: 7.94 MGD Average
  - b. Finished Drinking water deliveries through Booster Station 4A: 5.37 MGD Average
  - c. Finished Drinking water deliveries through Booster Station 5A: 1.50 MGD Average
  - d. Raw water delivery to Las Campanas at BS2A: 21.56 MG Total.
- 2. The BDD is providing approximately 70 percent of the water supply to the City and County for the month.
- 3. Please see the following pages from the Monthly report to the Office of the State Engineer (OSE) for accurate information up to May 15, 2016.

#### Drought, Monsoon/El Nino, and ESA Update

Drought conditions have eased this past year due to the reappearance of a strong El Nino, although February – May has been relatively dry. NOAA's latest update indicates that El Nino conditions are present, but weakening rapidly with increasing likelihood for La Nina conditions to develop by the summer (hot/dry) conditions, with about a 75% chance of La Nina during fall and winter 2016/17. Dry conditions in 2016/17 could present significant challenges to all water purveyors, water utilities, and irrigators if there is not significant filling and carry-over storage in regional reservoirs from the current run-off season. Regional reservoir levels on the upper Santa Fe River, Rio Grande, and Chama Rivers are still low but rising due to warmer temperatures and resultant snowmelt runoff. Preliminary estimates are for an approximate 90% delivery of full firm-yield of San Juan-Chama Project water. There are no water-related Endangered Species Act (ESA) updates. Updates on ESA issues will be made as needed. Rio Grande Compact Article VII storage restrictions went back into effect 4/22/16, which means the City will not be allowed to impound "native" runoff into Nichols and McClure Reservoirs above the pre-Compact pool of 1,061 AF (unless an exchange for water is made with the NMISC). Updates to this condition will be made as needed.

#### Item and Issue:

Request approval for Amendment #3 to the Legal Services Agreement with Long, Komer & Associates, P.A. in the amount of \$202,000 exclusive of NMGRT, for fiscal year beginning July 1, 2016 thru June 30, 2017.

#### **Background and Summary:**

On January 13, 2015 the Buckman Direct Diversion Board approved our request to award RFP #15/3/P' for legal services to Long, Komer & Associates, P.A. to serve as the legal counsel for the Buckman Direct Diversion Board. This request will extend the award for services July 1, 2016 to June 30, 2017, which is year two within the allowed extension period. This amendment will increase compensation for the amended term in the amount of \$202,000 exclusive of NM Gross Receipts Tax.

#### **Scope of Services:**

- Provide legal support services to the BDD Board, with particular reference to matters of administrative law, at all public BDD Board meetings and hearings;
- Represent the Board in litigation not covered by insurance and in administrative matters,
- Providing legal advice on state and federal permitting such as, but not limited to; 1) the Environmental Impact Statement (EIS) for the BDD 2) NEPA 3) the Biological Opinion covering the BDD, and 4) NPDES permitting for the BDD.





- Advise and represent the BDD on the public procurement process, including but not limited to, review of procurement documents, participation in required negotiations, assistance with solicitations, review and preparation of contracts;
- Advise and represent the BDD Board on legal matters related to Project funding, operations, construction, warranty, repairs and replacement, other residual issues on existing contracts, and management plans as directed by the Board;
- Prepare written opinions, resolutions, contracts, and other documents necessary to assist
  the Board with implementation, operation and management of the BDD as directed by the
  Board;
- Attend all Board meetings and relevant meetings of the governing Body of the City of Santa Fe, the BDD Board or County Commissioners, and BDD Staff meetings;
- Brief BDD Support Entity Partners' officials and staff members, as directed by the BDD Board; and
- Perform other duties as may be directed by the BDD Board or PUD Director or designee.

#### **Action Requested:**

Staff recommends approval of Amendment #3 to the Legal Services Agreement with Long, Komer & Associates, P.A. in the amount of \$202,000 exclusive of NMGRT for legal services through June 30, 2017. Funding is available in our approved FY2016/2017 operating budget.

# BUCKMAN DIRECT DIVERSION BOARD AMENDMENT No. 3 TO LEGAL SERVICES AGREEMENT ACTING IN THE CAPACITY OF LEGAL COUNSEL FOR THE BUCKMAN DIRECT DIVERSION BOARD #15-0153

This Amendment No. 3 (the "Amendment") to the Legal Services Agreement, dated February 22, 2015, and as subsequently amendment (the "Agreement"), is made between the Buckman Direct Diversion Board (the "BDDB") and Long, Komer & Associates, P.A. (the "Contractor"). The date of this Amendment shall be effective as of the date it is executed by the BDDB.

#### RECITALS

- A. Under the terms of the Agreement, Contractor has agreed to provide legal services to the Board.

#### Item and Issue:

Request approval for Amendment #3 to the Professional Services Agreement with Chavez Security in the amount of \$139,000 exclusive of NMGRT, for fiscal year July 1, 2016 thru June 30, 2017.

#### **Background and Summary:**

On December 4, 2014 the Buckman Direct Diversion Board approved our request to award RFP #15/06/B for security service to Chavez Security. #### **Issue and Item**

Staff requests approval to purchase water treatment plant chemicals for the Buckman Direct Diversion (BDD) from various chemical vendors in a total amount not to exceed \$250,000 for fiscal year 2016/2017.

#### **Background**

The BDD uses various chemicals to treat surface water in compliance with State and Federal Drinking Water Standards. Quantities are based on anticipated flows and estimated dosages as determined by operations. In July of 2013, the BDD solicited bids (BID# '14/04/B) for chemicals used in the water treatment plant process. The BDD is exercising the option in the contract to extend the purchase of goods for an additional year, which is the final year allowed within the extension period.

#### **Extension Process**

All current suppliers have kept the BDD chemicals supplied efficiently with no issues. Staff has submitted extension requests to each supplying vendor, in which all extensions have been accepted. Therefore staff recommends awarding the contract to the following bidding suppliers.

**Subject:** Consideration of Extension to the Term of the PMFSA

#### **ITEM AND ISSUE:**

Discussion and possible action to extend the term of the Project Management and Fiscal Services Agreement (PMFSA) from June 30, 2016 to December 31, 2016.

#### **BACKGROUND AND SUMMARY:**

The Staff Advisory Group recommended that the Buckman Direct Diversion Board select the City of Santa Fe to continue to serve as the Support Entity for the BDDB and enter into a new agreement for support services with a term through June 30, 2020. The Board adopted the Staff Advisory Group's recommendation. The original term of the PMFSA was December 31, 2015 but was extended to June 30, 2016 to allow time for the negotiation of a new agreement.

Negotiations have been ongoing regarding the terms of the new Support Entity Agreement. It is unlikely that the new agreement will be finalized prior to the expiration of the term of the PMFSA which is June 30, 2016. It is therefore recommended that the term of the PMFSA be extended through December 31, 2016, It is expected that the new Support Entity Agreement can be completed prior to that time.

#### **RECOMMENDATION:**

It is recommended that the Board approve Amendment No. 5 to the PMFSA, extending the term of the agreement to December 31, 2016. The amendment must also be approved by the City of Santa Fe.

# PROJECT MANAGEMENT AND FISCAL SERVICES AGREEMENT BUCKMAN DIRECT DIVERSION PROJECT

This Amendment No. 5 to the Project Management and Fiscal Services Agreement (hereinafter referred to as "Amendment No. 5") is entered into by and between the Buckman Direct Diversion Project Board (the "BDD Board"), an entity organized and existing under that certain Joint Powers Agreement by and between the City of Santa Fe ("City") and Santa Fe County ("County"), dated March 7, 2005, and the Sangre de Cristo Water Division of the City of Santa Fe ("Project Manager").

WHEREAS, the BDD Board and the Project Manager entered into the Project Management and Fiscal Services Agreement (the "Agreement") for the Buckman Direct Diversion Project ("Project") on November 8, 2007;

WHEREAS, the purpose of the Agreement was to specifically describe the duties and responsibilities of the BDD Board, the duties and responsibilities of the Project Manager, how the project will be operated and maintained by the Project Manager on behalf of the BDD Board, how contributions by the partners will be paid and credited against the obligations in connection with the Buckman Direct Diversion Project, the duties and responsibilities of the Project Manager as fiscal agent for the Project, and other necessary terms;

WHEREAS, the Agreement was amended pursuant to Amendment No. 1 to the Agreement to increase the Project Manager's monetary authority to enter into contracts and expenditures for the Project from \$20,000 to \$30,000; pursuant to Amendment No. 2 to the Agreement to increase the Project Manager's monetary authority from \$30,000 to \$50,000; pursuant to Amendment No. 3 to the Agreement to clarify that the monetary authority is

exclusive of gross receipts tax; and pursuant to Amendment No. 4 to extend the term of the Agreement; and

WHEREAS, the BDD Board and the Project Manager desire to enter into this Amendment No. 5 to further extend the term of the Agreement.

**NOW, THEREFORE**, for the covenants, promises and consideration described in this Amendment No. 5, the BDD Board and the Project Manager agree as follows:

- 1. **ARTICLE 2, TERM, EFFECTIVE DATE,** is amended to extend the term of the Agreement effective as of July 1, 2016 to December 31, 2016.
- 2. In all other respects, the Agreement shall remain in full force and effect in accordance with its terms.

#### **ITEM AND ISSUE:**

Consideration of approval of Amendment No. 2 to the Legal Services Agreement with Sheehan & Sheehan, P.A. ("LSA"), to extend the term and increase the compensation of the Agreement.

#### **BACKGROUND AND SUMMARY:**

At the conclusion of the procurement process for litigation legal services, the Board approved entering into a LSA with Sheehan & Sheehan, P.A. on December 3, 2015. The LSA was initially funded with \$30,000. The LSA was amended in February 2016 to fully fund the LSA for the FY16 fiscal year in the amount of \$900,000.00 for a total contract amount of \$930,000.00. Funding was anticipated to be added yearly along with the extension of the term of the LSA.

#### **RECOMMENDATION:**

It is recommended that the Board approve Amendment No. 2 to the LSA to extend the term of the contract by one year, terminating on June 30, 2017 and increase the compensation by \$300,000 for FY17.





### AMENDMENT NO. 2 TO THE LEGAL SERVICES AGREEMENT WITH SHEEHAN & SHEEHAN, P.A.

This Amendment No. 2 (the "Amendment") to the Legal Services Agreement, dated December 3, 2015, and subsequently amended (the "Agreement"), between the Buckman Direct Diversion Board ("BDDB") and Sheehan & Sheehan, P.A. ("Contractor") shall be effective as of the date when it is executed by the Board Chair.

#### RECITALS

- A. Under the terms of the Agreement, Contractor has agreed to provide professional legal services to the Board.
- B. Pursuant to Article 19 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the BDDB and Contractor agree as follows:

#### 1. **COMPENSATION**

Article 2 of the Agreement is amended to increase the amount of compensation by a total of three hundred thousand dollars (\$300,000) plus applicable New Mexico Gross Receipts Tax, so that Article 2, paragraph A reads in its entirety as follows:

A. The BDDB shall pay to Contractor in full payment for services, costs and fees incurred, a sum not to exceed one million two hundred thirty thousand dollars (\$1,230,000), plus New Mexico Gross Receipts Tax.

#### 2. TERM AND EFFECTIVE DATE

The term of the Agreement is amended to extend the Agreement termination date from June 30, 2016 to June 30, 2017.

#### 3. AGREEMENT IN FULL FORCE

Except as specifically provided in this Amendment, the Agreement remains, and shall remain, in full force and effect, in accordance with its terms.
