## August 6, 2015

This meeting of the Santa Fe County/City Buckman Direct Diversion Board meeting was called to order by Councilor Carmichael Dominguez, Vice Chair, at approximately 4:30 p.m. in the Santa Fe City Council Chambers, 200 Lincoln Avenue, Santa Fe, New Mexico.

#### 3. APPROVAL OF AGENDA

## 5. **APROVAL OF MINUTES:** July 2, 2015

Staff had no changes to the minutes as published.

Commissioner Chavez moved to approve the BDD Board minutes of the July 2, 2015 meeting. Councilor Maestas seconded and the motion passed by unanimous [4-0] voice vote.

#### MATTERS FROM THE PUBLIC

Vice Chair Dominguez invited input from the public and none was offered.

## MATTERS FROM THE BOARD

COMMISSIONER CHAVEZ: I just have a quick question of staff regarding the diversion project. Has there been any down time in the last month that you can share with us because of turbidity or whatever conditions?

CHARLES VOKES (BDD Facilities Manager): Chair Dominguez and members of the Board, we have had some turbidity incidents that have caused us some down time. When the river gets over 600 NTUs we typically don't pump the water. We have also had some LANL events including the most recent one. I guess they had a lot of

rain this past weekend and we are still down as a result of that. There is still flow in the canyon so we are not pumping water. We are anticipating maybe within the next day or two bringing the BDD back onboard. But what we've been doing with the majority of the rainfall events is we'll have maybe a half-day delay or something like that, we'll fill the plant up and get it as full as we can and then we've had to shut down. That's been pretty typical of the operations in the last month.

COMMISSIONER CHAVEZ: And so in doing that you'll have enough raw water to process from the holding tanks, from the sediment tanks? Is that how it is working?

MR. VOKES: Yes, sir. Those tanks hold eight million gallons so we can parse it out. I think the demand with the City has been fairly low, six or seven million gallons a day. Typically what we have been trying to do is just keep the plant in service and pump 2 or 3 million gallons a day. We've been pretty successful in doing that. I think, to my knowledge, this week's shutdown is the first time we've actually been down for any period of time.

COMMISSIONER CHAVEZ: And when the facility is down are you sharing that information with anyone? With the public or how do you –

MR. VOKES: Yes, sir. We are always in communication with the City and the County and Las Campanas. And, typically when we go down like you stated, I believe Mike Dozier sent out an email this week. I assume that the Board members were copied. I don't remember if any of you got those but I did see an email that he sent out and I believe your names were on that.

COMMISSIONER CHAVEZ: I may have overlooked it which happens often but I will just pay more attention than in the future. And then maybe in my part I may have to stay in communication or establish communication with staff on a more regular basis too.

MR. VOKES: Certainly.

COMMISSIONER CHAVEZ: Thank you, Mr. Chair.

MS. BOKUM: Following up on that, I wonder if it wouldn't be a good idea to have a little square someplace on the website that provides that information to people.

MR. VOKES: Okay.

MS. BOKUM: Because I think that's the kind of transparency that if somebody is upset that we're not being transparent would complain about and I think we should be transparent.

MR. VOKES: Certainly, certainly. I'll ask Ms. Padilla to look into that.

Thank you.
