Subject: Update on BDD Operations for the Month of January 2016

ITEM:

- 1. This memorandum is to update the Buckman Direct Diversion (BDD) Board on BDD operations during the month of January 2016. The BDD diversions and deliveries have averaged, in Million Gallons Daily (MGD) as follows:
 - a. Raw water diversions: 3.77 MGD Average
 - b. Finished Drinking water deliveries through Booster Station 4A: 2.76 MGD Average
 - c. Finished Drinking water deliveries through Booster Station 5A: 0.74 MGD Average
 - d. Raw water delivery to Las Campanas at BS2A: 0.0 MG Total.
- 2. The BDD is providing approximately 51 percent of the water supply to the City and County for the month.
- 3. Please see the following pages from the Monthly report to the Office of the State Engineer (OSE) for accurate information up to December 15, 2016.
- 4. Please note all prior years are also included for reference.
- 5. The current Drought Update Summary is attached and reservoir storage status.

Drought, Monsoon/El Nino, and ESA Update

Drought conditions have eased this past year due to the reappearance of a strong El Nino. NOAA's latest update (01/21/16) indicates that El Nino Conditions are present, and that El Nino is expected to remain strong through the winter 2015-16, with a transition to neutral conditions during late spring or early summer 2016. Dry conditions in 2016 could present significant challenges to all water purveyors, water utilities, and irrigators going forward into the summer if there is not significant filling and carry-over storage in regional reservoirs. Regional reservoir levels on the upper Santa Fe River, Rio Grande, and Chama Rivers are still low but rising slowly. The City has received about 93% of total San Juan-Chama Project firm yield for the year (2015); however, there were no deliveries in August through December. There are no water-related Endangered Species Act (ESA) updates. Updates on endangered species issues will be made as needed. Rio Grande Compact Article VII has been invoked, which means the City cannot impound runoff into Nichols and McClure Reservoirs above its pre-Compact pool of 1,061 AF (unless other arrangements are made to access either its SJCP "exchange pool" and/or the ISC's "relinquishment pool.)" Updates to this condition will be made as needed. It is anticipated that Article XII will be lifted sometime around mid-February.

6,943 AF SJCP carry-over from previous years, no time limit to vacate due to storage agreement with ABCWUA

Subject: 4th Quarter of 2015 Update on Environmental Compliance

NPDES Program

BDD maintained compliance with its NPDES permit.

SDWA Program

- **★** BDD and NMED sampled the finished drinking water in 2015. Those results confirmed BDD maintained compliance with the safe drinking water standards.
- ♣ BDD posted on its web site the analytical results from 2015.

Solid Waste Disposal Program

- By the end of December 2015, BDD has processed 2,306 tons of solid waste. In comparison, the 2014 amount was 1,180 tons of solid waste.
- Waste analyses of the solids demonstrated that disposed solids met the contaminants' limits set for non-hazardous waste, and therefore, BDD maintained compliance with its Disposal Management Plan.

BDDB & LANL MOU - Early Notification System and Water Quality Monitoring Program

- → BDD prepared a MOU Report which presented and analyzed the results from the 2011 through 2014 MOU programs.
- ➡ BDD implemented a new surface water monitoring program based on the renewed 2015 MOU between DOE/LANL and BDD Board.
- More than 500 samples were collected during the summer season 2015, processed and sent for analyses to the contract laboratory.
- → BDD hired interns from state universities to help with this program. BDD interns collected more than 500 samples and they analyzed 114 surface water samples at BDD laboratory.

RCRA Waste Disposal Program

♣ BDD recycled approximately 1,000 lbs of batteries.

EPCRA Program

★ The 2015 Tier II Report (BDD Chemical Inventory) was submitted to NM DHSEM.

Appointment of Citizen Member and Alternate Citizen Member to the BDDB

ITEM AND ISSUE:

Appointment of the citizen member and alternate citizen member (on a provisional basis) to the Board.

BACKGROUND AND SUMMARY:

The Joint Powers Agreement ("JPA") establishing the Buckman Direct Diversion Board (BDDB) provides for the appointment of a citizen member to the Board by a majority vote of the four other members of the Board. The term of the citizen member is two years and the current citizen member's term expired on January 7, 2016. Mrs. Bokum may continue to serve for sixty (60) days beyond the expiration of her term under the current JPA.

The Board voted to recommend amendment of the JPA to provide for an alternate citizen member. The amendment was passed by the City Council at the January 2016 board meeting. We are awaiting approval by the Board of County Commissioners. Then the amendment must be approved by the New Mexico State Department of Finance & Administration.

The Board advertised for the citizen member position and alternate citizen member position by placing public notice in the Santa Fe New Mexican, and on the BDD's and City's website for 2 weeks in December. Four applications were received and interviews were conducted in January.

The interview committee consisted of BDDB Chair Liz Stefanics, BDDB Vice Chair Carmichael Dominguez, Charles Vokes, Facilities Director and Bernardine Padilla, Public Relations Coordinator.

RECOMMENDATION:

Chair Stefanics and Vice Chair Dominguez will give their recommendations for the citizen Board member seats to the BDD Board members for decision and vote. The new citizen board member will begin on the Buckman Direct Diversion Board effective March 3, 2016. The alternate citizen member will be provisionally appointed until the amendment to the JPA is fully approved.

ITEM AND ISSUE:

Adoption and approval of Contingency Fund Policy

BACKGROUND AND SUMMARY:

The BDDB has had some unexpected events and developments requiring funding. The events, including the necessity of funding possible litigation the Board may pursue, are not covered by the regular budget nor covered by other established funds. The fund will be limited at this time to cover litigation fees and related costs.

Contributions to the Contingency Fund will be based on the percentages each partner contributed to the construction of the BDDB facility as follows:

City - 47%
County - 47%
Las Campanas - 6%

RECOMMENDATION:

It is recommended that the Board adopt the Contingency Fund Policy, attached hereto, to provide funding for litigation and costs related to the litigation.



Buckman Direct Diversion Board Contingency Fund Policy

In alignment with the BDD Project intergovernmental agreements and in order to secure resources for the BDDB's participation in litigation, the BDDB wishes to establish a Contingency Fund to cover litigation fees and related expenses.

The Contingency Fund will be funded by the BDDB partners.

The purpose of this policy is to set forth how the fund will be initially funded and the process for adding additional contributions to the fund, how to obtain access to the funds, and how the Contingency Fund will be replenished once the funds had been utilized.

Initial Funding

The Contingency Fund shall be initially funded in the amount of One Million Dollars (\$1,000,000.00), for fiscal year 2015/2016. Additional amounts added to the fund will be made by the BDD partners as part of the regular, yearly budget process (or more frequently if necessary) for so long as it is determined that the Contingency Fund is necessary and advisable. The partners will contribute to the Contingency Fund according to the same percentages contributed to the construction of the Buckman Direct Diversion Project as follows:

City of Santa Fe: 47% Santa Fe County: 47% Las Campanas: 6%

<u>Purpose</u>

The Contingency Fund shall be designated as a restricted special revenue fund. Expenditures shall be made in accordance with this policy and billed to our partners for reimbursement.

Maintenance of the Contingency Fund

All funds will be monitored by the BDD Financial Manager and may earn interest income on cash balances. The Board will determine yearly, as part of its budget process or more frequently during the year, as may be required, the contributions to be made to the Contingency Fund.

All funds shall be budgeted and expended in accordance with the policies and procedures established in the Project Management and Fiscal Services Agreement and the BDD Working Capital and Billing Policy.

ITEM AND ISSUE:

Consideration of approval of Amendment No. 1 to the Legal Services Agreement with Sheehan & Sheehan, P.A. ("LSA"), to increase the compensation under the LSA for fees, services and costs by \$900,000.00 plus New Mexico Gross Receipts Tax.

BACKGROUND AND SUMMARY:

At the conclusion of the procurement process for litigation legal services, the Board approved entering into a PSA with Sheehan & Sheehan, P.A. on December 3, 2015. The LSA was initially funded with \$30,000 while staff was tasked with establishing a process for obtaining additional funds from the partners to fully fund the LSA. That process has now been established through adoption of the Contingency Fund Policy.

RECOMMENDATION:

It is recommended that the Board approve Amendment No. 1 to the LSA to increase the compensation under the PSA by \$900,000.00 plus NMGRT in order to fund the LSA for litigation fees and costs and for expert expenses.





AMENDMENT NO. 1 TO THE LEGAL SERVICES AGREEMENT WITH SHEEHAN & SHEEHAN, P.A.

This Amendment No. 1 (the "Amendment") to the Legal Services Agreement, dated December 3, 2015, (the "Agreement"), between the Buckman Direct Diversion Board ("BDDB") and Sheehan & Sheehan, P.A. ("Contractor") shall be effective as of the date when it is executed by the Board Chair.

RECITALS

- A. Under the terms of the Agreement, Contractor has agreed to provide professional legal services to the Board.
- B. Pursuant to Article 19 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the BDDB and Contractor agree as follows:

1. COMPENSATION

Article 2 of the Agreement is amended to increase the amount of compensation by a total of by nine hundred thousand dollars (\$900,000.00) plus applicable New Mexico Gross Receipts Tax, so that Article 2, paragraph A reads in its entirety as follows:

A. The BDDB shall pay to Contractor in full payment for services, costs and fees incurred, a sum not to exceed nine hundred thousand dollars (\$900,000.00), plus New Mexico Gross Receipts Tax.

2. AGREEMENT IN FULL FORCE

Except as specifically provided in this Amendment, the Agreement remains, and shall remain, in full force and effect, in accordance with its terms.
