Subject: Update on BDD Operations for the Month of November 2019

#### ITEM:

- 1. This memorandum is to update the Buckman Direct Diversion Board (BDDB) on BDD operations during the month of November 2019. The BDD diversions and deliveries have averaged, in Million Gallons Per Day (MGD) as follows:
  - a. Raw water diversions: 3.622 MGD.
  - b. Drinking water deliveries through Booster Station 4A/5A: 3.408 MGD.
  - c. Raw water delivery to Las Campanas at BS2A: 0.0 MGD.
  - d. Onsite treated and non-treated water storage: 0.214 MGD Average.
- 2. The BDD is providing approximately 58.8% percent of the water supply to the City and County for the month.

- 4. The BDD year-to-date diversions are depicted below:







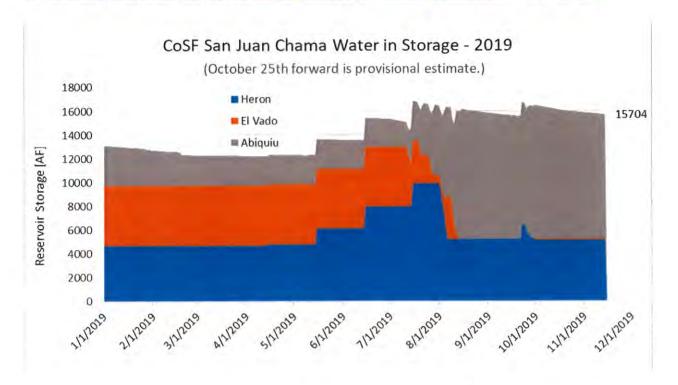
#### San Juan Chama

On November 14<sup>th</sup>, total storage of San Juan Chama (SJC) water in Chama system reservoirs was approximately 15,704 AF (5180 AF in Heron, 117 AF in El Vado, and approximately 10,417 AF in Abiquiu). This is a provisional estimate based on communication with USBR staff. The last verified values are from October 24<sup>th</sup> with 15,965 AF total storage (5180 AF in Heron, 118 AF in El Vado, and 10,667 AF in Abiquiu). See Figure 2. The City of Santa Fe received a full allocation of 5230 AF of SJC water in 2019. The Water Division has experienced some difficulties in accessing San Juan Chama storage data from the Upper Rio Grande Water Operations Model (URGWOM) and had been reporting extrapolated estimates in PUC reports. As pointed out by Councilor Ives in the November PUC meeting, San Juan Chama storage values reported prior to November 2019 did not match the annual values reported in that meeting. The 2019 values being reported here through October 24<sup>th</sup>, 2019 are consistent with URGWOM accounting values.

#### **ENSO Outlook**

As of November 18<sup>th</sup>, ENSO-neutral (neither El Niño nor La Niña) conditions are favored during the Northern Hemisphere winter 2019-20 (~70% chance neutral, ~23% chance El Niño), continuing through spring 2020 (60-65% chance neutral, continued ~23% chance for El Niño).

Process for Appointment of New Citizen Member and Alternate Citizen Member

#### Item and Issue:

Process for appointment of the citizen member and alternate citizen member to the Buckman Direct Diversion Board (BDDB).

#### **Background and Summary:**

The Joint Powers Agreement ("JPA"), as amended, establishing the BDDB, provides for the appointment of a citizen member and alternate citizen member to the BDDB by a majority vote of the four other voting members of the BDDB. The term of the citizen member and alternate citizen member is two years, and the current members were re-appointed for another two-year term in March 2018. The current terms for both the citizen member and alternate citizen member expire on March 3, 2020.

The BDDB staff advertised for the citizen member position and alternate citizen member position by placing public notices in the *Santa Fe New Mexican*, and on the BDDB's, the City's and County's websites. The initial deadline for receiving applications was October 31, 2019 and was extended to November 30, 2019. It is now timely to conduct interviews and make recommendations to the BDDB.

#### **Action Requested:**

The BDDB staff and attorney seek direction on the appointment of the citizen members. The last time a selection process was conducted, a committee consisting of the Chair, Vice-Chair and the Facilities Manager held the interviews and made recommendations to the full board. The selection process this time could follow the same process or proceed otherwise as the Board determines.

Amendment No. 4 Alpha Southwest, Inc.

#### **ITEM AND ISSUE:**

Request for approval of Amendment No. 4 to the contract with Alpha Southwest for the BDD Raw Water Pump Project, Bid No. 16/38/B.

#### **BACKGROUND AND SUMMARY:**

In 2016 the Buckman Direct Diversion Board awarded RFB '16/38/B "BDD Raw Water Pump Project" to Alpha Southwest, Inc. to construct and install four (4) raw water pumps at Booster Station 1A (BSA1) and four (4) raw water pumps at Booster Station 2A (BS2A) for a total contract amount of \$1,009,472.50. The scope of work includes manufacturing, installation and testing of the eight new vertical turbine pumps with the use of the existing motors.

In 2017 a change order was approved in the amount of \$38,527.02 for the purpose of upgrading the thrust bearings in the existing motors. During the manufacturing phase it was determined the existing motors that were for the raw water pumps at BS2A needed extra high thrust bearings.

In 2018 a change order was approved in the amount of \$27,718.71 to correct the misalignment, including machining the pipe flanges and adjustment of pipe supports to allow for a satisfactory installation of the pump. The remainder of the change order was to allow the contractor to provide oil bath mechanical seals instead of a stuffing box with packing rings. This change order was for one pump. The changes made to the pump were successful, and the pump has run for five weeks with no issues. As of 11/21/2019 only a slight amount of oil has been added to the supply tank.

This request is to approve a change order to provide the funding to continue with the oil lubricated mechanical seal setups with an added heavy seal to prevent any material getting to the new seal on three more pumps. In addition to the purchase of 4 vertical clamp couplings to allow for seal replacement without pulling the electric motor and help stop vibration of the pump. This request will increase the contract by \$68,974.37 for a total contract amount of \$1,144,692.61.

The BDDB has authorized these expenditures from the Major Repair and Replacement fund. Therefore this request includes approval of a Budget Amendment Resolution (BAR) to cover the additional cost.



#### **ACTION REQUESTED:**

Staff recommends approval of Amendment No. 4 to the contract with Alpha Southwest, Inc. to increase the contract amount by \$70,215.82 for a total amount of \$1,145,934.06 and approval of the Budget Adjustment Resolution (BAR) from the Major Repair and Replacement Fund.

#### Major Repair & Replacement Fund:

#### BUCKMAN DIRECT DIVERSION BOARD AMENDMENT No. 4 TO THE AGREEMENT WITH ALPHA SOUTHWEST, INC.

This AMENDMENT No. 4 (the "Amendment") to the Agreement between Owner and Contractor dated August 4, 2016, and subsequently amended (the "Agreement"), is made between the Buckman Direct Diversion Board (the "BDDB") and Alpha Southwest, Inc. ("Contractor"). The effective date of this Amendment shall be the date it is executed by the BDDB.

#### RECITALS

WHEREAS, under the terms of the Agreement, Contractor agreed to provide professional services to the BDDB to remove, construct and install four (4) raw water pumps for the Buckman Direct Diversion's Booster Pump Stations 1A and 2A, pursuant to Bid No. 16/38/B for the BDD Raw Water Pump Project ("the Bid");

WHEREAS, the Bid contained Alternative Bid Items which included up to four (4) additional pumps that could be purchased by the BDDB within one year of the Agreement;

WHEREAS, pursuant to Amendment No. 1 to the Agreement, the BDDB elected to purchase four (4) additional pumps as provided for in the Alternate Bid Items;

WHEREAS, pursuant to Amendment No. 2 to the Agreement, the BDDB approved a change order request for parts needed in the construction of the four (4) 2A raw water pumps for the BDD Raw Water Pump Project;

WHEREAS, pursuant to Amendment No. 3 to the Agreement, the BDDB approved a change order request, related to field conditions at one pump installation and two modifications to the proposed sealing system for the BDD Raw Water Pump Project; and to extend the time of completion;

WHEREAS, Contractor has submitted a request for a change order, related to changes to the sealing system at three (3) pump installations and changes to the vertical clamp couplings of four (4) pumps for the BDD Raw Water Pump Project; and to extend the time of completion;

WHEREAS, the BDDB wishes to approve the change request and increase the Contract Sum in Article 4, paragraph 4.1;

WHEREAS pursuant to Article 10.22 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the BDDB and Contractor agree as follows:

#### 1. Change Order

The change order request for necessary parts and labor in the amount of Sixty-Three Thousand Six Hundred Seven and .49/100 Dollars (\$63,607.49) plus applicable gross receipts tax and to extend the time of completion to June 30, 2020 is approved.

#### 2. <u>Contract Sum</u>

Article 4, Contract Sum, of the Agreement is amended so that Article 4, paragraph 4.1 reads in its entirety as follows:

4.1 The Owner shall pay Contractor in current funds for the performance of the Work, subject to additions and deductions by Change Order as provided in the Contract Documents, the Contract Sum of One Million One Hundred Forty-Four Thousand Six Hundred Ninety-Two and .61/100 Dollars (\$1,144,692.61).

The Contract Sum is determined as follows:

Re: BDD Board Communications on Water Quality Issues

#### **Item and Issue:**

This memo summarizes the correspondence from the BDD Board to various parties related to water quality issues from 2019. The list below is organized by topic, several of the letters from the Board contain references to multiple subjects and are thus listed under multiple categories below.

#### **Background and Summary:**

Please note that the Board received a response from NMED Secretary Kenney on September 27, 2019 regarding a number of these topics.

#### 1. State Water Quality Regulation:

- June 7, 2019 letter to New Mexico Congressional Delegation setting forth the water quality priorities of the Board requesting additional funding, and identification of LANL cleanup priorities to prevent contaminated run-off from impacting the Rio Grande.
- June 7, 2019 letter to the Governor and Secretary of NMED setting forth the water quality priorities of the Board, including enforcement of the state Water Quality Control Act, including establishment of a TMDL for contaminants in the BDD source water area; requesting that NMED continue to engage with LANL on the basis of the 2005 Consent Order; and re-establishment of monitoring station E-109.9.

#### 2. LANL MOU:

 June 7, 2019 letter to the Governor and Secretary of NMED setting forth the water quality priorities of the Board and re-establishment of monitoring station E-109.9 located in LA/Pueblo Canyon, under the BDD LANL MOU.

#### 3. Comments on "Waters of the United States" (WOTUS) Proposed Rule:

 April 12, 2019 letter to EPA setting forth the Board's comments in opposition to proposed definition of Waters of the United States to exclude certain ephemeral streams from Clean Water Act jurisdiction.

#### 4. Comments on Proposed Rule Updating Water Quality Certification (Section 401 of Clean Water Act):

• October 21, 2019 letter to EPA setting forth Board's comments in opposition to proposed rule affecting state certification of federal water quality permits.

#### 5. Nuclear Watch New Mexico Litigation:



- October 30, 2019 letter to Governor Lujan-Grisham setting forth the Board's support of the Nuclear Watch New Mexico position in the litigation over NMED and DOE's adoption of the 2016 Order on Consent replacing the 2005 Consent Order for cleanup of hazardous and mixed wastes at LANL and asking that the Governor direct NMED to change its position in that litigation.
- October 30, 2019 letter to NMED Secretary Kenney setting forth the Board's support of the Nuclear Watch New Mexico position in the litigation over the 2016 Order on Consent, and requesting that NMED change its position in the litigation, or withdraw from the lawsuit and establish a new monitoring framework based upon the 2005 Consent Order.
- October 30, 2019 letter to Angelica Rubio, Chair of the Radioactive and Hazardous Waste Materials Committee setting forth the Board's support of the Nuclear Watch New Mexico position in the litigation over the 2016 Order on Consent and requesting that the Committee direct NMED to change its position in the litigation, or withdraw from the lawsuit and establish a new monitoring framework based upon the 2005 Consent Order.

#### 6. Amigos Bravos Petition for MS4 Designation for Los Alamos County:

• November 7, 2019 letter to NMED Secretary James Kenney acknowledging NMED's support of Designation and requesting NMED engagement in Amigos Bravos litigation.

#### 7. Comments on Suspension of DOE Order 140.1 Amigos Bravos Petition for MS4 Designation for Los Alamos County

 June 7, 2019 letter to Congressional Delegation, DOE Secretary Perry and DNFSB Chair Hamilton setting forth the Board's position on the potential effects of DOE Order 140.1 on the ability of DNSFB to perform its duties.
